

AUTHORIZATION FOR THE PROCESSING OF PERSONAL DATA OF COLOMBIA MIGRATION USERS

As the Owner of my personal information, I authorize in an informed, express and prior manner without payment or remuneration to THE SPECIAL ADMINISTRATIVE UNIT MIGRACIÓN COLOMBIA (hereinafter MIGRACIÓN COLOMBIA) identified with NIT. 900.477.235-6, to its successors, assigns or whoever represents or holds its rights, so that directly or through third parties they collect, store and in general process my personal information, whether through physical, magnetic, digital or any other, including information of a financial, credit, commercial, professional, technical and administrative nature, sensitive, private, semi-private or of any nature, past, present or future, contained in any physical, magnetic, digital or electronic, among others and without limitation to documents, photos, recordings, biometric data, emails and video recordings (hereinafter "Personal Data"):

The authorization that I grant to MIGRACIÓN COLOMBIA allows the Treatment and the following purposes:

- 1. Carry out the activities of your mission and vision.
- 2. Carry out my registration and connection as a migrant in the physical and automated databases of MIGRACIÓN COLOMBIA, as well as carry out all the pertinent procedures related to my immigration status.
- 3. Develop the products, services and procedures offered by the Entity.
- 4. Verify, corroborate, verify, validate, investigate or compare the information provided by me.
- 5. Receive information about the services, programs and projects offered by MIGRACIÓN COLOMBIA.
- 6. Transfer and/or transmit my personal data to entities or third parties as a result of an agreement, program, project, law or legal link that requires it or to implement interoperability services with other public entities for the fulfillment of the purposes described.
- 7. Transfer and/or transmit data to third parties inside and outside the Colombian state with whom MIGRACIÓN COLOMBIA makes agreements or alliances related to its mission or activities, or with whom it contracts studies or entrusts them with the Processing of personal data.
- 8. Contact me by email, postal mail, text messages (SMS), by telephone, via WhatsApp or by any other means of communication known or to be known by virtue of the execution of the indicated purposes.
- 9. Keep my information for commercial, analytical, statistical and historical purposes and/or to comply with legal obligations regarding the conservation of personal information and documents



Likewise, I declare that I am aware that MIGRACIÓN COLOMBIA recognizes that certain data submitted to Processing may have the quality of sensitive data or be of minors and the answers to the questions that have been asked or will be asked of me about said personal data are optional in accordance with with current regulations. I declare that I have not been forced to respond, so I voluntarily and expressly authorize the Processing of my sensitive data to be carried out, especially those related to my health status and biometric data.

The personal data provided may circulate and be transferred to all areas of MIGRACIÓN COLOMBIA, including service providers and/or data processors, contractors, delegates, outsourcing, outsourcing, network of offices or allies that work on behalf of MIGRACIÓN COLOMBIA with the The objective is to develop system hosting services, maintenance services, analysis services, messaging services by e-mail or physical mail, delivery services, management of payment transactions, collections, among others. Consequently, the Owner understands and accepts that through this authorization he grants these third parties authorization to access their Personal Data to the extent that they require it for the provision of the services for which they were contracted or the development of the activities. that occur within the framework of the social statutes of MIGRACIÓN COLOMBIA.

By granting this authorization, I declare that the Personal Data provided is true, verifiable and complete, in addition to having been informed of my right to know, update and rectify my Personal Data.

MIGRACIÓN COLOMBIA informs that the Treatment of your personal information will be carried out in accordance with the Personal Data Processing Policy which can be consulted on the website https://www.migracioncolombia.gov.co/planeacion/politica-de-tratamiento- personal data. The user declares that he knows that the rights that assist him as the owner of the information are the following:

- 1. Know, update and rectify your personal data that resides in the databases;
- 2. Request proof of the authorization granted;
- 3. Be informed by the Entity, upon request, regarding the use that has been given to personal data;
- 4. Submit complaints to the Superintendency of Industry and Commerce for violations of the law;
- 5. Revoke the authorization and/or request the deletion of your data when a current legal or contractual relationship or obligation is not maintained;
- 6. Access information for free.

The Owner of the data, or his successors, may consult the information that resides in the databases in the possession of MIGRACIÓN COLOMBIA, as well as present complaints or requests for information related to the protection of their personal data, for which they must formulate the written request, and file it in the PQRS button available at the following link https://www.migracioncolombia.gov.co
